



# GS1Locatenet Schedule of Fees (Effective from January 1st 2010)

GS1Locatenet is a Global Location Number (GLN) Directory Service. Through the use of GS1Locatenet, trading partners are able to share and synchronise accurate and up to date GLN data for a range of business locations including Price Locations, Ship-To Location, Bill-To Locations, E-Messaging Location and many others.

Accurate Location Data is an essential and critical first step toward achieving efficient B2B transaction management, inventory management, accurate traceability (both upstream and downstream) and even critical for accurate and efficient product recalls.

GS1Locatenet has been designed by industry, for industry, as a central standards-based repository of GLN data to meet the common needs of Australian industry across all sectors.

GS1 Australia is a not-for-profit trade standards organisation. GS1Locatenet is operated by GS1 Australia, on behalf of industry, on a user pays cost recovery basis. A single standardised GS1Locatenet Schedule of Fees applies to all industry sectors.

Registration with GS1Locatenet is only available to **financial members** of GS1 Australia. The fees associated with the use of GS1Locatenet vary based on a company's annual turnover.

## Schedule A – GS1Locatenet Fees

The Joining and Monthly Fees associated with the use of GS1Locatenet are outlined below.

The fee model is designed to ensure that GS1Locatenet remains accessible by all organisations on a cost recovery basis. This is achieved by utilising the company's revenue turnover and is consistent with the approach taken to calculate other GS1 membership and service fees.

## Fee Waiver for National Product Catalogue Users

### **Until 30 June 2011**

GS1Locatenet will be made available free of charge to all registered users of the National Product Catalogue (NPC/GS1net) until 30 June 2011. That is, there will be no joining fee and all ongoing fees will be waived during this period.

Companies not registered with the NPC, may register for the NPC first and then have free access to GS1Locatenet until 30 June 2011.

### **From 1 July 2011 onwards**

On and after 1 July 2011 NPC registered users that have registered for GS1Locatenet will have the option to Opt-in or Opt-out of this service. Those that Opt-In will begin paying the GS1Locatenet Fees as specified in this document and will continue to have access to GS1Locatenet. Those that Opt-Out, will incur no costs but access to GS1Locatenet will be terminated.

**Please note:** Joining Fees are fully waived for NPC registered users that register for GS1Locatenet prior 30 June 2011).

## Billing

GS1Locatenet fees are invoiced annually in advance prior to the start of each new financial year based on the fees specified in Schedule A (above).

Fees due at registration will include the Joining Fee and the first year's access fees. The first year's fees will be calculated pro-rata, based on the number of months from registration to the end of the current financial year.

For example, an organisation registering for the service in April 2011 will have access to the service during FY2010-2011 for a total of three (3) months to end June 2011, before renewal is due. In this example the fees will be the Joining Fee plus three (3) months access fees in advance based on the organisation's annual turnover.

## Fee Inclusions

- A fully hosted, individual electronic catalogue for each registered company for the purpose of providing centralised and standardised location data with an unlimited number of participating GS1Locatenet trading partners.
- Hosting of obsolete GLNs (GLNs that have been set as inactive in the GS1Locatenet), for a minimum 4-year period, free of charge.
- An unlimited number of changes or updates can be made to GLN records resulting in an unlimited number of "Auto Alerts" to GS1Locatenet trading partners.
- Unlimited access to GS1Locatenet to manage your organisation's GLN data as well as Search & Download functions across the entire GS1Locatenet Directory via the web browser interface.
- An unlimited number of company-assigned, individual User IDs to provide individual staff members access to the GS1Locatenet web browser interface within a range of security access levels.
- Telephone and email support from the GS1 Client Services Team.

## Fee Conditions

- The GS1Locatenet fees are incremental to the GS1 Australia membership fees.
- Registration with GS1Locatenet is only available to financial members of GS1 Australia.
- Each GS1Locatenet registration must correspond to a single GS1 Australia membership.
- Companies registering for GS1Locatenet that do not wish to disclose their annual turnover can register for the service without making the declaration. In this case, the annual fees applicable will be those specified for the highest Annual Turnover bracket (Level F).
- GS1 Australia reserves the right to resolve differences where a declared turnover for GS1Locatenet differs from turnover details recorded for the purposes of GS1 Australia subscription membership or other services.
- Registration with GS1Locatenet is subject to the user accepting the Terms and Conditions of Use as published by GS1 Australia.
- GS1Locatenet fees do not include any costs associated with the use of the Internet or any other middleware products designed to support GS1Locatenet.
- It is the responsibility of the GS1Locatenet user to provide and maintain a personal computer, modem, other hardware and/or Internet services (including browser software and Internet service provider) required for accessing and using the service. Where security settings on a personal computer, network or firewall act to impede normal access to and functioning of GS1Locatenet, then it is the user's responsibility to seek an IT resolution locally.
- GS1 Australia reserves the right to change the Fee Schedule and conditions by providing 14 days written notice.

## Definitions

- **GLN (Global Location Number)** are used to uniquely identify physical locations or legal entities. The key is comprised of a GS1 Company Prefix, Location Reference, and Check Digit.
- **Financial Member** is an organisation that has executed a GS1 Australia Subscription Membership and License Agreement with GS1 Australia and is financially current.
- **Auto Alerts** are the electronic message notifications that GS1Locatenet automatically sends to a user upon a trading partner making a change to their GLN data.
- **User IDs** are User Company assigned, unique and individual user identification to provide access to the GS1Locatenet web browser interface. Registration with GS1Locatenet entitles each company to create and assign multiple User IDs to individual staff members.
- **Search & Download** provides users with the ability to search across the entire GS1Locatenet Directory. It provides users with the ability to download GLN data from GS1Locatenet..
- **Gross Annual Company Turnover** is deemed to be the aggregate Australian based revenue of your organisation including all related companies for a twelve month period, regardless of the number of products utilising the GS1 system. For Government and statutory organisations, revenue includes income from the sale of products as well as any Government appropriations, contributions, subsidies or other Government distributions and funding.
